



## TIPPING COMPETITION AT THOROUGHbred PARK

### TERMS AND CONDITIONS OF ENTRY

*Managed by Canberra Racing Club (CRC)*

#### Who can enter

- The Thoroughbred Park - Canberra Racing Club (the Club) tipping competition is open to current financial members only. Committee members are not eligible to participate.
- The Club reserves the right to request proof of identity.

#### Opening/closing dates and times

- The Competition runs on race days from 1 July 2019 continuously until the Club ends the term of the Competition. The Club will notify members via email at least two months prior to the competition ending.
- For each Competition, the Club will publish the nominated race date and open the Competition for entries by no later than 1:00pm on the date two days prior to the nominated race date.
- Entries are submitted for each Competition via the Thoroughbred Park Website. Entries to the Competition will always close prior to the start of the first of the six nominated races for the given Competition.

#### How to enter

- To enter a Competition, go to [www.thoroughbredpark.com.au](http://www.thoroughbredpark.com.au), select the Members Tipping Competition.
- Click the 'Tip Now' button; Fill in your details; Enter your horse numbers in the fields; Submit your tips.
- Select one runner from each of the last six races and follow the instructions on the web page to submit your entry. Once the entries have closed,

entrants cannot change their Picks for the Competition.

- Entrants must submit their final Picks prior to the closing time specified for each week of the Competition.
- By entering Picks the entrant agrees to be bound by these terms and conditions. Any information published at the Entry Points about the Competition form part of these Terms and Conditions. The Club reserves the right in its sole discretion to disqualify any entrant who the Club reasonably believes has breached any of these Terms and Conditions.
- If any Pick is a late scratching (scratching's are finalised on race morning) in any race then the starter with the lowest saddlecloth number is substituted e.g. if horse number 5 is selected and is scratched it will be replaced by horse number 1 and if horse number 1 is also scratched it will be replaced by horse number 2 and so on. If any one to five of the six races is abandoned then the Competition for that day is also abandoned and the prize jackpots. If all six races are abandoned then that day's prize is not added to the jackpot.

#### Cost of entry

Entry to the competition is free.

#### Maximum number of entries

Only one entry is allowed per Member, per Competition. Multiple entries will void all entries for the Member.

## **Prize**

- The pool starts at \$1,000. If not won an additional \$1,000 is added per race meeting; the entrant needs to select one horse in each of the last six races held at Thoroughbred Park each race meeting; if their 2 selected horses wins all six races they win the jackpot; if there are multiple winners on the day the pool is shared i.e. four winners with a pool of \$3,000 = \$750 each. Once won the pool returns to \$1,000 for the next Competition. For Competition purposes the winner of each race is as determined by the Stewards on the day. The total prize pool is capped at \$100,000.

## **Winner selection**

The winning entrant/s for each Competition will be selected in accordance with these terms and conditions.

## **Winner notification**

- The names of winner/s will be published on the Website.
- Winners will be notified by email or telephone within 2 days. It is each entrant's sole responsibility to ensure that their contact details are up to date.
- Winners will be required to verify (with evidence satisfactory to the Club) their identity and other requested verification information to the satisfaction of the Club before they are eligible to receive a prize. Any public announcement will be pending verification unless otherwise stated and should not be considered final confirmation.
- If a winning entrant is not able, for any reason to accept a prize, verify their registration information to the satisfaction of the Club or has been found to have breached these terms and conditions by the Club then the entrant will be disqualified and the prize will be forfeited.
- If a winner cannot be contacted in accordance with the time period for winner contact set out above, or for any reason does not accept the prize, then that prize will be held by the Club for a further 7-day period. If by the end of such

period the Club has still been unable to contact the relevant winner or the winner has not accepted the prize for any other reason, that prize will be forfeited. The forfeited amount will be added back to the jackpot pool.

## **Prize fulfilment**

Prizes will be paid via deposit to each winner via bank transfer to a bank account nominated by the winner within 21 days of the winner selection.

## **Publicity and privacy**

- If you enter the Competition you agree that the Club may include and/or announce on the Thoroughbred Park website, on social media platforms and/or elsewhere at their discretion your membership number and details of any prizes that you have won and/or correct Picks that you have made.
- You also agree to do all things reasonably requested by the Club if you win any prizes, including by complying with the Club's reasonable request to use your name, likeness and/or voice in promotional material. You agree that all such material belongs to the Club and can be used for any length of time at its discretion.

## **Disputes**

If an entrant wishes to dispute the published outcome of a Competition they must do so within three days of the Competition by email to [canberracing@thoroughbredpark.com.au](mailto:canberracing@thoroughbredpark.com.au). The Committee of the Club will be the sole arbiter of any such dispute.
