# Centenary Canberra Cup Promotion – Terms and Conditions

#### 1. Promotion Overview

The Centenary Canberra Cup Promotion ("Promotion") is conducted by the Canberra Racing Club Inc. ("CRC"). The Promotion celebrates the 100th anniversary of the first running of the Canberra Cup in 2026 through the sale of a limited-edition Centenary Canberra Cup Cap. Purchase of a Cap provides eligibility to participate in the "Centenary Cup Day Owner Draw" and attend the Black Opal Cocktail Party.

## 2. Cap Sales

- Only 100 Centenary Canberra Cup Caps will be produced.
- Each Cap is priced at \$119 (AUD) including GST.
- Sales open exclusively to CRC Members from 20 October 2025.
- If not sold out, sales will open to the general public from 29 October 2025.
- Caps will be sold on a first-come, first-served basis.
- Each purchase is limited to one Cap per person until 6 November 2025.
- Purchases are non-refundable and non-transferable unless approved by CRC at CRC's absolute discretion.
- Purchases will be made available by CRC's website, thoroughredpark.com.au.
- Cap number requests can be made by the 'Additional comments' section of the purchase process but are not guaranteed.

### 3. Eligibility and Draw

- Each Cap purchaser ("Cap Owner") receives one entry into the Centenary Cup Day Owner Draw.
- The draw will take place at the Black Opal Cocktail Party on Friday, 6 March 2026
- The number of winners will correspond to the number of runners in the Canberra Cup race on Sunday, 8 March 2026.
- Each drawn winner ("Cup Day Owner") will be allocated one horse in the Canberra Cup.
- Cap purchasers can purchaser multiple Caps only from 6 November 2025.

- Cap purchasers are limited to drawing one horse. For example, from 6

  November 2025, a Cap purchaser can purchase multiple Caps but once drawn as a winner, their other Caps become ineligible to be drawn.
- Each Cup Day Owner will receive:
  - o Three (3) Owner's Passes for Canberra Cup Day.
  - Access to a special Race Day experience, including opportunities to meet the trainer and jockey of their allocated horse (subject to operational availability).
- CRC employees and Board are ineligible for the draw.

## 4. Race Day and Prize Details

- If a Cup Day Owner's allocated horse is scratched from the Canberra Cup after the draw, Cap owner will not receive a replacement horse or prize.
- The Winning Cup Day Owner (the owner of the horse Cap wins the Canberra Cup) will receive \$3,500 cash.
- The 2nd place Cup Day Owner will receive \$1,500 cash.
- The 3rd place Cup Day Owner will receive \$500 cash.
- Prizes are not transferable or exchangeable.
- Cash prizes will be paid via electronic transfer within 14 business days after the race.

#### 5. Experience and Engagement

CRC will endeavour to provide all Cup Day Owners with a memorable and authentic Race Day experience, including behind-the-scenes access, engagement with stables, and pre-race interaction with jockeys, where feasible. Experiences may vary due to Race Day logistics and racing considerations.

#### 6. General Conditions

- The Promotion is open only to individuals aged 18 years and over.
- CRC reserves the right to:
  - Verify the eligibility of entrants and purchases.
  - Cancel or modify the Promotion at any time if circumstances beyond CRC's control affect its operation.
- CRC's decisions regarding the Promotion are final and binding.
- By participating, entrants agree to be bound by these Terms and Conditions.
- CRC reserves the right to use the names and images of winning Cup Day Owners for promotional purposes, without additional compensation.

# 7. Privacy

Personal information collected for this Promotion will be handled in accordance with the Canberra Racing Club's Privacy Policy and used solely for the administration of the Promotion and related activities.

## 8. Liability

CRC accepts no responsibility for any loss, injury, or damage (including consequential loss) suffered or sustained as a result of participation in the Promotion, except where such liability cannot be excluded by law.

# 9. Governing Law

These Terms and Conditions are governed by the laws of the Australian Capital Territory.
