



Canberra Racing Club Kosciuszko 2026 Syndicate Terms and Conditions

1. **Entry:** Entry is open to persons aged 18 years or over who satisfy the eligibility requirements applying to The Kosciuszko sweepstakes with the exception of Canberra Racing Club employees who are excluded.
2. **Syndicate shares:** Each payment of \$50 purchases one share in the Canberra Racing Club Kosciuszko Syndicate. Multiple shares may be purchased. A share does not represent ownership of Canberra Racing Club, any sweepstakes ticket or any horse. Syndicate shares can be made at Thoroughbredpark.com.au.
3. **Purchase of tickets:** Funds received will be pooled and used by Canberra Racing Club to purchase official Kosciuszko sweepstakes tickets on behalf of the syndicate.
4. **Equal entitlement:** Each fully paid \$50 share carries an equal entitlement to any prize money ultimately received by the syndicate, regardless of when the share was purchased.
5. **No winning ticket:** If none of the syndicate's sweepstakes tickets are drawn, members will receive no payment and share purchases will not be refunded.
6. **Horse selection:** If the syndicate secures a Kosciuszko slot, the horse will be selected by an independent form panel of 3 experts appointed by Canberra Racing Club. The selection will be subject to the horse's eligibility and availability, agreement with its connections and the official Kosciuszko rules. The expert's decision will be final, and syndicate members will not vote on the selection. Canberra-trained horses may be preferenced where appropriate and in the best interest of the syndicate.
7. **Prize-money agreement:** Each member's entitlement will be calculated from the net prize money payable to the syndicate under that agreement, not from the horse's total advertised prize money.
8. **Unavailable or withdrawn horse:** If the selected horse becomes unavailable, Canberra Racing Club may ask the independent form expert to select a replacement, subject to the official rules and applicable deadlines.
9. **Payments:** Any distribution will be made after Canberra Racing Club has received the relevant funds and confirmed each member's entitlement. Members must provide accurate contact and payment details and are responsible for any personal tax obligations arising from a payment. Canberra Racing Club retains the right to retain funds related to costs incurred through the administration for the syndicate.
10. **Cancellation or changes:** If the sweepstakes or race is cancelled, postponed, abandoned or materially altered, members' entitlements will be determined by the official Kosciuszko rules and any amount actually received by Canberra Racing Club. Canberra Racing Club may reasonably amend these terms where required by Racing NSW, TAB, law or circumstances outside its control.
11. **Acceptance:** Purchase of a share constitutes acceptance of these terms and the official terms and conditions of The Kosciuszko sweepstakes. Gamble responsibly.
12. **Sweepstakes Authorisation:** NSW Permit No. GOCSC/1058 & ACT Permit No. C 26/00001. The Promoters of the sweepstakes are Racing NSW with the assistance of NSW TAB and ACT TAB. Canberra Racing Club is not a promoter of, and nor is a Related Body Corporate of the sweepstakes.
